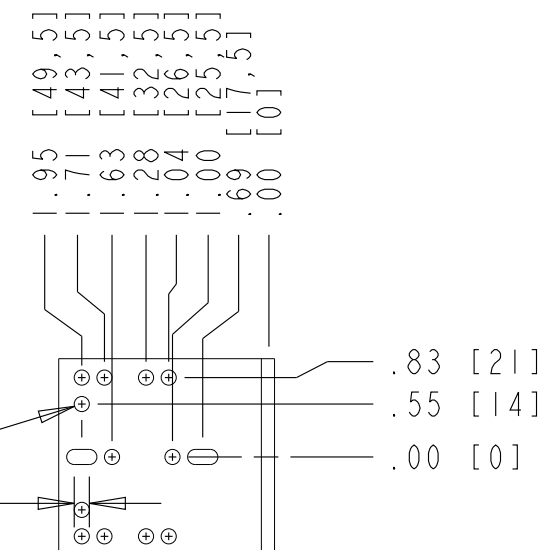



1. PRODUCT DESIGNED FOR 1.5" FACE FRAME CABINET.
2. UPPER TRAY EQUIPED WITH 400MM BALL BEARING FULL EXTENSION SLIDES.

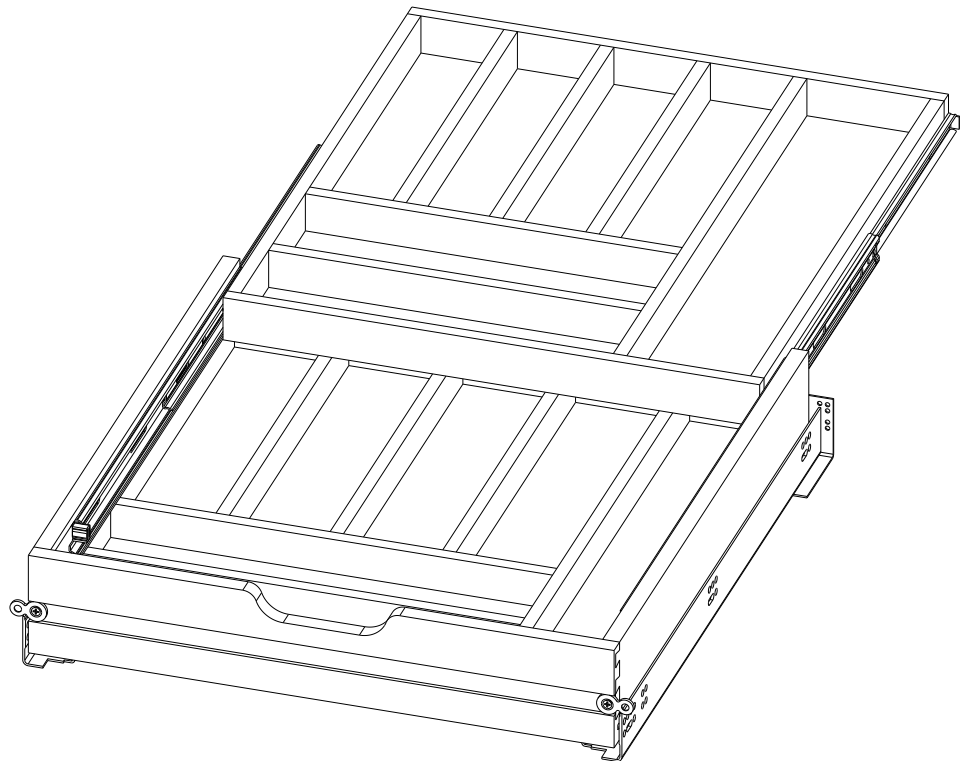


